- 2) Network (LAN) Restructuring at Computer Lab work will be under comprehensive warranty for full 12 (twelve) months from the date of completion at our Computer Lab under ICT Operation Division, Head Office. No EOL product will be allowed. Also product which will be EOL within next 03 (three) Years will not be allowed.
- 3) The Supplier have to ensure the quality of Structured Cabling components from the manufacturer along with part number/ manufacturer code (Purchase Document with same part number). Shipment details of the product should also be submitted before submission of bill.
- 4) The twisted pair cable used for communication cabling and patch cord will be CAT-6A/ CAT-6A+ or CAT-7 & have to maintain ITU CAT-6A/ Cat-6A+/CAT-7 Cable Standard and same color (Gray Preferable). Length of twisted pair cable may vary 10% from the mentioned quantity in the tender.
- 5) The Structured Cabling components (CAT-6A/ CAT-6A+/CAT-7 Cable, Cable Manager, Patch Panel, Patch Cord) will be same Brand/ Company (Mixup will not be allowed).
- 6) Bidder must have minimum 03 (three) years' experience in Structuring Cabling work at different reputed banks and/or Telco companies in Bangladesh. Bidder have to submit experience certificate. Tenderers having below 03 (three) years' work experience strongly advised not to submit tender documents.

- 7) Bidder may visit Computer Lab (A-A Bhaban, 8th Floor, 23, Motijheel-C/A, Dhaka -1000) under our ICT Operation Division of our Bank if seems necessary.
- 8) Supplier will complete the supply, installation and configuration within 15(fifteen) days of obtaining work order at Data Center, Head Office, Dhaka.
- In case of any trouble with the Structure Cabling the supplier shall have to repair the same free of cost at the premises where it will be in use within 4(four) hours. If the Computer Lab Network (LAN) Restructuring work is not in repairable, it must be replaced by a similar one within 24(four) hours from getting the information of trouble prior to taking/bringing the same at their end for repairing purpose. In case of failure of the supplier, the Bank shall have the right to get necessary repairing works done by other agency at the expense of the supplier. Such expense will be adjusted from the supplier's security money and the supplier shall have no objection to it.
- 10) Payment of the bills will be made from ICT Operation Division, Head Office, after delivery, installation and working properly of the same as per specification mentioned in the Supply Order.
- 11) 10% (ten percent) of the bill amount will be retained as Security Money or 10% (ten percent) of the bill amount as Bank Gurantee of 12 (twelve) months which will be paid/return to the supplier after expiry of the warranty period of 12 (twelve) months at the satisfaction of the purchaser.
- 12) All Tax, Vat, Govt. Duties etc. will be deducted from the bill as per rule prior to payment of the same.
- 13) The authority reserves the right either to accept or to reject all or any offer without assigning any reason.
- 14) Bank is not bound to accept the lowest Quotation. To be successful in the bid, quality of the offered items, financial capability and reputation etc. of the firm as assessed by the Bank are the prime factors for consideration.
- 15) Attested Photocopy of Trade License, TIN Certificate, VAT registration Certificate (if any), Financial Solvency Certificate, Appreciation letter, Major client List and Company profile must be submitted with the Ouotation.
