<u>Specification for IP based Camera:</u> Brand: any renowned brand, Model: Mentioned by the Bidder, Pixel: Minimum 2 Megapixel (1600x1200), Accessories: Include all necessary accessories. Others: Mentioned by the Bidder, True Day/Night Vision, Minimum IR Distance 25M.

<u>Specification for NVR:</u> Brand: any renowned brand, Channel: 04 Channels, Technical Specification: Mentioned by the Bidder, Accessories: Include all necessary accessories.

Specification for Hard Disk: Brand: any renowned brand, Capacity: 12 TB= (2 units X 6 TB).

Terms and condition:-

- 1. The CCTV Camera system supply and installation work at our ATM Booth of different location of our country to be completed on case to case basis. We will procure the same from the selected vendor as and when required for the next one year.
- 2. The CCTV Camera system have to capable of store minimum 1 year video footage with minimum resolution -1080P & 25 frame rate by using 2 pcs camera covering our above mentioned specification.
- 3. We will use 02 unit IP based Cameras and 01 unit NVR with 12 TB (2 unit 6 TB Hard Disk Drive) storage capacity for the ATM booth containing 01 (one) ATM. In case of 02(two) ATMs in an ATM Booth, we will use 03 unit IP based Cameras and 01 unit NVR with 12 TB (2 unit 6 TB Hard Disk Drive) storage capacity to ensure proper security measure.
- 4. The offer must be submitted through "Offering Sheet (Technical and Financial)" enclosed with the schedule.
- 5. The offer must be valid for one year.
- 6. Bidder should have minimum 3 (three) years experience in the relevant work.
- 7. Bidder must be an authorized distributor/reseller of the product.
- 8. In case of failure of the supplier, the Bank shall have the right to get the replacement works done by the other agency at the cost of the supplier. Such costs will be adjusted from the supplier's security money and the supplier shall have no objection to it.

- 9. An earnest money of 10% (Ten) of the bid value to be submitted in the form of Pay Order/Bank Guarantee in favour of Pubali Bank Limited from any scheduled Bank of Bangladesh with the quotation along with the financial offer. Tender security will be refunded to the unsuccessful bidders.
- 10. 10% (ten percent) of the bill amount will be retained as Security Money which will be paid to the supplier after expiry of the warranty period at the satisfaction of the purchaser.
