**1. Eligibility of the bidder:**


- a. The principal of the ATM vendor shall have more than **10 years** of experience in ATM supply worldwide.
  - b. The bidder or the principal should have at least **3 years** of experience of undertaking for ATM supply and installation for scheduled banks in Bangladesh. Besides, related Electrical works are to be done through license holder issued by Electricity licensing Board.
  - c. The bidder shall supply ATM's from authorized manufacturer only.
  - d. The bidder shall have at least **03 or more successful projects** of supplying ATM locally in scheduled Bank of Bangladesh
  - e. The bidder shall have adequate support engineers and capability for support & service at any location of our Bank within schedule time.
2. The offer must be submitted through "**Technical and Financial sheet**" enclosed with this notice.
  3. The amount (**Unit rate of ATM**) is to be quoted both in figures and in words properly in BDT. The quoted rate must be inclusive of finished jobs including total handling of materials, incidental charges-overhead, all types of taxes and VAT as per prevailing government rules, delivery, installation, manual labour charge and any kind of charge thereof.
  4. Delivery of ATM may be at any branch of Pubali Bank Limited as per our supply order.
  5. Bank will procure ATM and related electrical wiring system from the selected vendor on case to case basis as and when required to meet up our future requirement within 01 (one) year period.

9. Payment of the bills will be made from Card Operation Division, Head Office through Payment Order, after successful **delivery & installation** of the **ATMs** at the Branch/office/location of our Bank and also fulfill all others terms & conditions of the Supply Order.
10. Necessary **VAT & TAX** will be **deducted** from the bill as per prevailing government rules prior payment of the same.
11. The successful bidder shall have to inform the Bank **02 (Two)** month before if they want to discontinue supply of the ATM to our Bank.

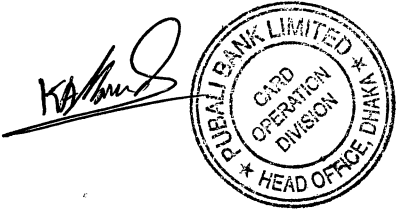

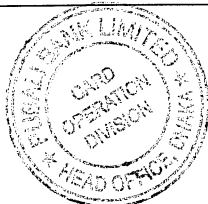
