**Terms and Conditions:**

**1. Eligibility of the bidder:**

- (i) The principal of the card supplier shall have more than 10 years of experience in banking card production and personalization worldwide.



- (ii) The bidder should have at least **5 years** of experience of undertaking for magstripe and EMV Chip contact Card supply as well as **02 years** of experience of undertaking for EMV Chip contactless Card supply in scheduled banks of Bangladesh.
- (iii) Bidder shall have at least **5 (five) projects** for supplying EMV cards locally in different scheduled Banks of Bangladesh.
- (iv) The bidder shall supply EMV Card from VISA certified card manufacturer only.
2. The total amount is to be quoted both in figures and in words properly in BDT. The quoted rate must be inclusive of finished jobs including total handling of materials, incidental charges-overhead, all types of Taxes and VAT as per prevailing government rules, carrying cost, manual labour charge and any kind of charge thereof.
  3. **10 pieces** of sample Cards for each type of products with approved design has to be submitted in prior to the commercial production.
  4. Amount of **Tender Security is Tk. 5,00,000/-** (Taka five lac only) which will be in the form of **Payment Order** in favour of Pubali Bank Limited **which must be issued from any branch of Pubali Bank Limited**. Tender security will be refunded to the unsuccessful bidders. **Performance security is 10%** (Ten percent) for successful bidder which will be accepted in the form of Bank Guarantee and will be retained for 1(One) year on award of order.
  5. Failing to supply the Card total or part thereof within the given time period, each week delay will charge **2%** of total work order amount as penalty and will be deducted from final payment.
  6. In the event of supply any item which do not match with the required specification, quantity or sample's quality the bank reserves the right for outright rejection of the goods and the supplier will have to take back those at their own cost and will replace with bank demand.
  7. Payment of the bills will be made from Card Division, Head Office through Payment Order, after successful delivery of the **ordered Cards** and also fulfill all others terms & conditions of the Supply Order.
  8. Necessary **VAT & TAX** will be **deducted** from the bill as per prevailing government rules prior payment of the same.
  9. The authority reserves the right either to accept or to reject all or any offer without assigning any reason.


