- 6) The Supplier have to ensure the quality of Access Control System from the manufacturer along with part number/ manufacturer code (Purchase Document with same part number).
- 7) Bidder should have more then 05 (five) years' experience serving different solutions in reputed banks and/or Telecom Companies in Bangladesh. Bidder having experience of 03 (three) years' in relevant field/ access control system may also submit tender documents.
- 8) In case of any trouble with the Access Control System within the warranty period the supplier shall have to replace/repair the item free of cost at installed location of our Bank where it will be supplied within 24 (twenty four) hours. If the Item is not in repairable condition on the premises, it should be replaced by a similar one within 24 (twenty four) hours from getting the information of trouble prior to bring the same at their end for repairing purpose. In case of failure, the Bank shall have the right to get the replacement or repairing works done by other agency at the cost of the supplier. Such costs will be recovered from the supplier and the supplier shall have no objection to it.
- 9) Payment of the bills will be made from ICT Operation Division, Head Office, after delivery, installation and working properly of the same as per specification mentioned in the Supply Order.
- 10) 10% (ten percent) of the bill amount will be retained as Security Money or 10% (ten percent) of the bill amount as Bank Gurantee which will be paid/return to the supplier after expiry of the warranty period of 03 (three) years at the satisfaction of the purchaser.
