- 4. Bank Guarantee and SBLC (Standby LC) Operations: Handle Guarantee, Counter Guarantee and Standby Letter of Credit (SBLC) related operations. This includes verifying the authenticity and validity of the documents, ensuring compliance with regulations and internal policies, and facilitating smooth transactions between the applicant and the beneficiary. Provide guidance and assistance to clients regarding the proper utilization of Guarantees and SBLCs in international trade.
- 5. Trade Compliance: Stay updated with international trade regulations, sanctions, and embargoes to ensure compliance with all relevant laws and regulations. Conduct due diligence on export transactions and monitoring for any potential compliance risks.
- 6. **Export Risk Management:** Regular visits to export clients' factories/organizations to evaluate their business. Risk Analysis, exporter Analysis, business and market analysis, price verification of exported goods, and eligibility of Back to Back amount against master LC determination.
