1. Eligibility of the bidder:

- (i) The principal of the local vendor shall have more than 10 years of experience in EMV machine manufacturing, supplying and software support worldwide.
(ii) The bidder or the principal should have at least 05 years of experience of undertaking for supplying required machine with software solution at scheduled banks/any reputed organization in Bangladesh.
(iii) The bidder shall have at least 02 or more successful projects of supplying required machine with software solution locally in scheduled Bank/ any reputed organization in Bangladesh.
(iv) The bidder should have in-house capabilities to provide required software and hardware support as per Banks' requirements.



- (v) The bidder should have an adequate number of trained personnel for the related service work at our Bank.
- (vi) The bidder has to inform the Bank about the source of supply of required machine with software solution and Bank reserves the right to reject the bid in case the source of supply is not disclosed.
2. The offer must be submitted through “**Financial Offer & Technical Offer**” enclosed with this notice.
 3. The successful bidder will complete the supply, installation, configuration and required card script completion for production environment within 04 (four) months of obtaining work order. In case of any trouble with EMV Chip Based Card Personalization Machine with EMV Software and Contactless Card Solutions function/parts within the **warranty period**, the supplier shall have to replace/repair the **product** within 24 (twenty four) hours. In case of failure of the supplier, the Bank shall have the right to get the replacement/repairing works done by the other agency at the cost of the supplier. Such costs will be adjusted from the supplier's security money and the supplier shall have no objection to it.
 4. The total amount is to be quoted both in figures and in words properly in BDT. The quoted rate must be inclusive of finished jobs including total handling of materials, incidental charges-overhead, all types of Taxes and VAT as per prevailing government rules, carrying cost, manual labour charge and any kind of charge thereof.
 5. The amount of **Tender Security is Tk. 10,00,000/-** which will be in the form of **Payment Order** in favour of Pubali Bank PLC. or **Bank Guarantee** of the same amount will be accepted. Tender security will be refunded to the unsuccessful bidders. **Performance security is 10%** (Ten percent) for successful bidder which will be accepted in form of Payment Order or Bank Guarantee and will be retained for 01 (One) year on award of order. Without tender security **no** tender will be accepted.
 6. Failing to supply & install the machine within the given time period, each week delay will charge **2%** of total work order amount as penalty and will be deducted from final payment.
 7. In the event of supply any function which does not matches with the required specification and quantity, the bank reserves the right for outright rejection of the goods and the supplier will have to take back those at their own cost and will replace with bank demand.
 8. Payment of the bills will be made from Card Operation Division, Head Office through Payment Order, after successful delivery of Banks' requirement and also fulfill all other terms & conditions of the Supply Order.
 9. Necessary **VAT & TAX** will be **deducted** from the bill as per prevailing government rules prior payment of the same.



10. The authority reserves the right either to accept or to reject all or any offer without assigning any reason.
11. Bank is not bound to accept the lowest Quotation. To be successful in the bid, quality of the offered items, financial capability and reputation etc. of the tenderer as assessed by the Bank are the prime factors for consideration.


